

INSTRUCTION SHEET
PD-815SC-PBSH
RSH SERIES RACKMOUNT POWER

NOTES:



PD-815SC-PBSH will not fit between rackrail if attached prior to installation. Power Strip must be attached after rackshelf installation.



- Choose a rackmount shelf in the enclosure where the power strip will not impede cable management.
- The strip may be mounted upside-down to save space by turning the entire assembly over before mounting. Use cable strain relief on plugs when mounting upside down.

INSTALLATION

- Install power strip and insert and push plastic rivets into the holes on the top (**FIGURE A**) and bottom (**FIGURE B**) of the clamps and rackshelf. Four rivets per top / bottom.
- To remove the power strip from the shelf, insert a screwdriver between the rivets and push them back open. Lift each rivet out, reversing the assembly steps.

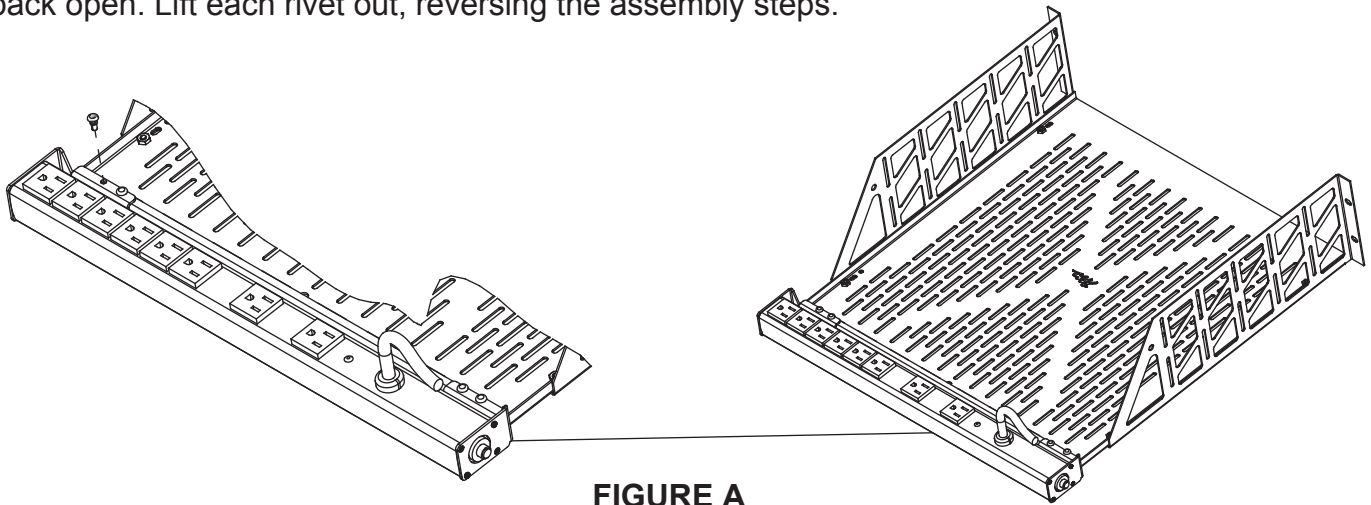

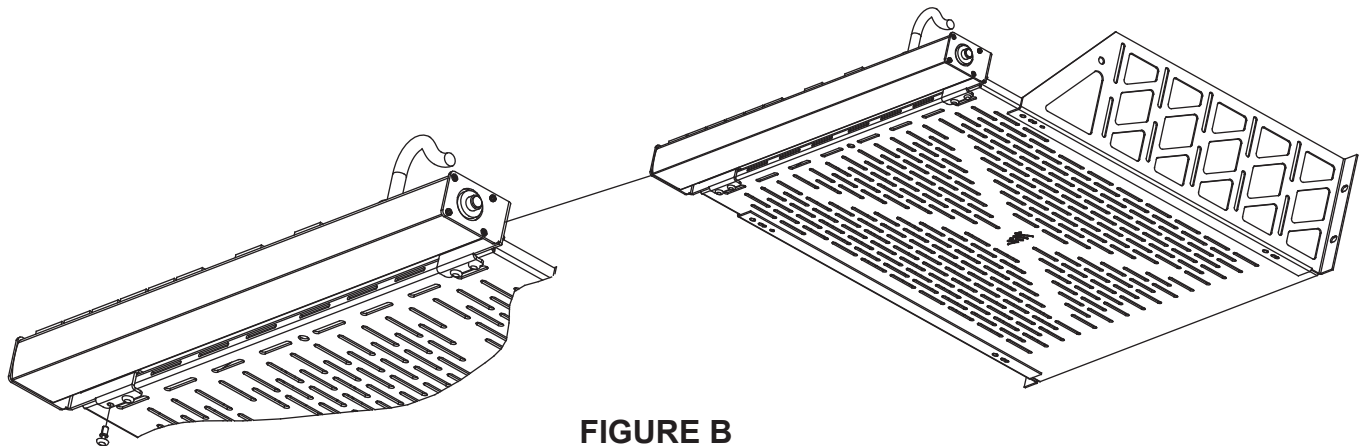
