## KYLK/LATCH

### DOOR/DRAWER ASSEMBLY

- 1) Remove the knock-out from the door.
- 2) Remove the screw from the back of the KYLK/LATCH.
- 3) Install the KYLK/LATCH on the door as shown. (FIGURE A)

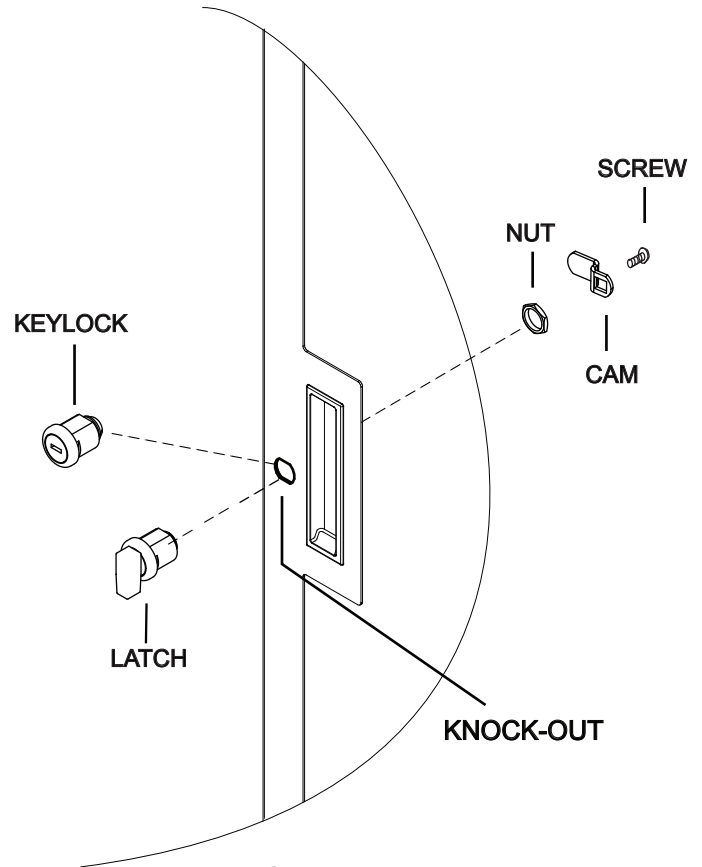

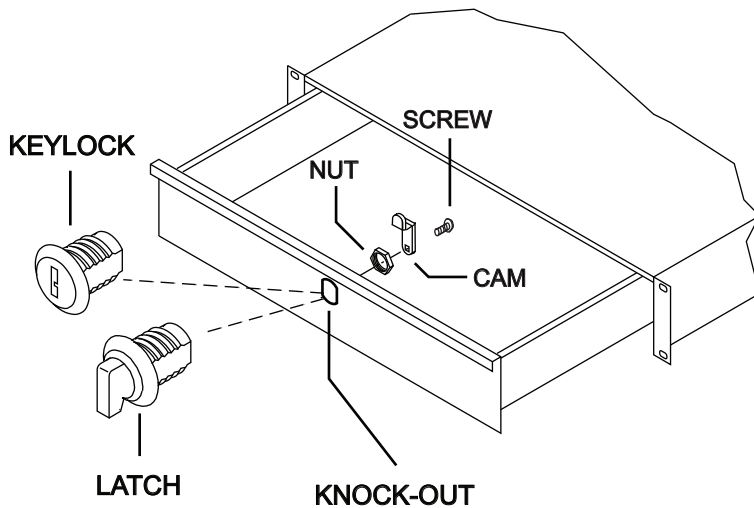

- 2) Remove the screw from the back of the KYLK/LATCH.
- 3) Install the KYLK/LATCH on the drawer as shown. (FIGURE B)
