The Reference Product comes from sites that have received ISO 14001 certification.

Specific distances of transport before and after manufacturing were not available, but based on the use of local suppliers and sale within in North America, "Local transport" default distance of 621 miles (1,000 km) by heavy truck to the manufacturing site and to local distribution centers was included in the manufacturing stage.



### DISTRIBUTION

Products are distributed from logistics centers located to optimize transport efficiency using EPA SmartWay<sup>\*</sup> certified carriers to reduce greenhouse gases emissions. Information on the distance of distribution is not available so the PCR hypothesis for "Intercontinental transport", 2175 miles (3500 km) by heavy truck, was used. This represents transportation of the Reference Product from our warehouse to the local point of distribution in the North American market.


