## Installation

- 1.** Connect the adapter's USB Type-C connector to the USB-C port on your laptop, tablet or other compatible device.
- 2.** Connect the adapter's VGA port to the monitor's VGA port using a VGA cable (such as Tripp Lite's P502-Series VGA cables).
- 3.** Charge your device by connecting its USB-C charger to the adapter's USB-C port.
- 4.** Connect a USB device to the adapter's USB-A hub port.
