The Reference Product comes from sites that have received ISO 14001 certification.



### DISTRIBUTION

Products are distributed from logistics centers located to optimize transport efficiency using EPA SmartWay® certified carriers to reduce greenhouse gases emissions. Information on the distance of distribution is not available so the PCR hypothesis for "Intracontinental transport", 2175 miles (3500 km) by heavy truck, was used. This represents transportation of the Reference Product from our warehouse to the local point of distribution in the United States market.

It does not pre-validate the effective use of this channel for end-of-life electrical and electronic products.

### ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use, and end of life. It is representative of products marketed and used in United States.

The following modelling elements were taken into account:

<b>Manufacturing</b>	Packaging taken into account. As required by the PEP ecopassport program, all transport for the manufacturing of the Reference Product, including materials and components, has been taken into account. The waste generated during manufacturing phase has been taken into account.
<b>Distribution</b>	Transport between the last distribution center and an average delivery to the sales area. The default scenario modelled maximizes the environmental impact using the PCR hypothesis for "Intracontinental transport": 2175 miles (3500 km) by heavy truck.
<b>Installation</b>	The end of life of the packaging ( 0.42 lb or 193.04 g) is taken into account at this phase. Transport of packaging to end of life treatment.

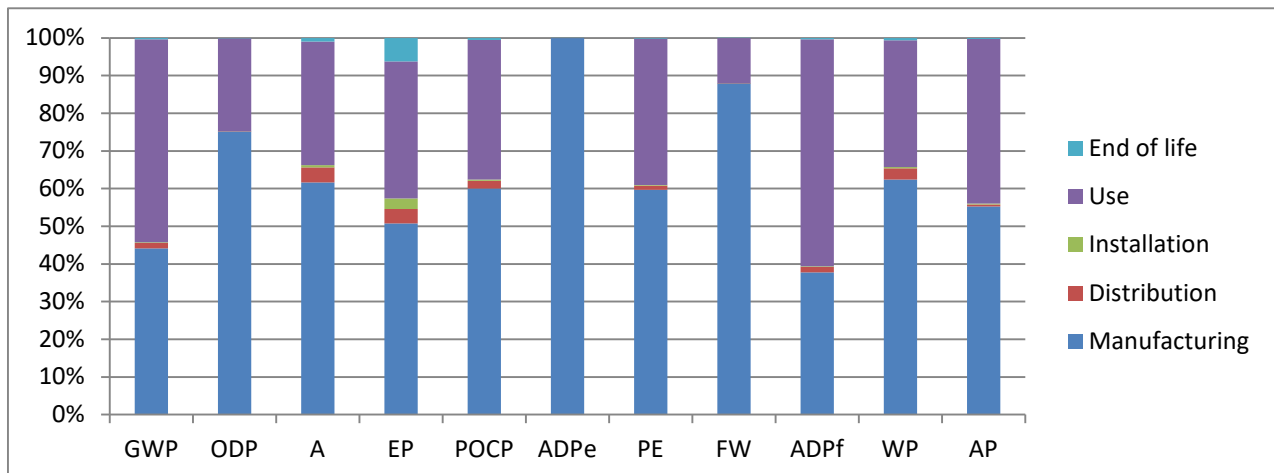

For products other than the Reference Product, the environmental impacts are estimated by weighting the environmental impacts of the Reference Product by the values shown in the table below. Impacts for manufacturing are proportional to the mass of the reference product. For products sold in the European market, apply the variable 'E' to the values shown for Distribution and Use. This represents international transportation of 19000km by boat and 1000km by truck. Impacts for Use are proportional to the power dissipation based on the connector category (Cat 6). Impacts for Installation and End of Life is proportional to the mass of the Reference Product. The PEP has been developed taking into account the number of connection points. The effective impact of the product shall be calculated by the PEP user multiplying impacts by the number of product connection points.
