■ DISTRIBUTION

Products are distributed from logistics centers located to optimize transport efficiency using EPA SmartWay® certified carriers to reduce greenhouse gases emissions. The Reference Product is therefore transported over an average distance of 1648 miles by truck from our warehouse to the local point of distribution into the market in North America.

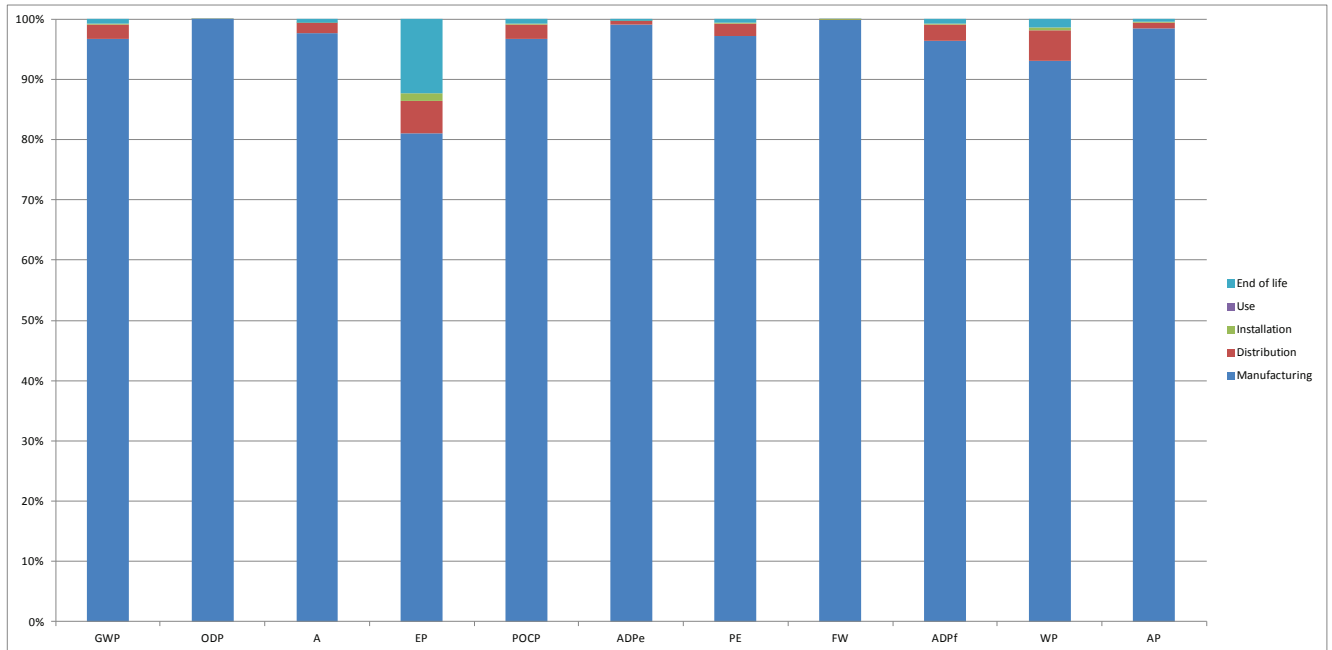
