## How to Claim

To claim your rebate, you must complete the following steps.

**STEP 1:** Conduct the device swap either through your dealer account with AlarmNet 360 or your central station account.

**STEP 2:** Visit [fire.honeywell.com/promotions/alarmnet](https://fire.honeywell.com/promotions/alarmnet). Completely fill out the form and submit.

Upon validation of your upgrade, your **\$50 rebate from Resideo will be sent to you** based on the contact information you provided at [fire.honeywell.com/promotions/alarmnet](https://fire.honeywell.com/promotions/alarmnet). For rebate payment timing, please see below.

## Rebate Payment

For accounts that have been upgraded and have had rebates applied for between 5/1/2021 and 8/31/2021, you will receive the rebate no later than 9/30/2021.

For accounts that have been upgraded and have had rebates applied for between 9/1/2021 and 12/31/2021, you will receive the rebate no later than 1/30/2022.
