HOW TO CLAIM YOUR REBATE

Device rebate is only available to customers with existing AlarmNet 3G/4G device accounts.

To claim your rebate, you must complete **BOTH** of the following steps.

STEP 1: Conduct the device swap either through your dealer account with [Alarmnet 360](#) or your central station account.

STEP 2: Click [here](#) to claim your rebate. Upon validation of your upgrade, your \$50 rebate will be sent to you by AlarmNet based on the contact information you provided and in accordance with the program rules.

PROGRAM RULES

THE OFFER PERIOD IS FROM MAY 1, 2021 UNTIL MARCH 31, 2022

- Rebates will be paid according to the following timelines:
 1. All accounts that complete the Rebate Claim Process on or before Aug. 31 will receive the rebate payment no later than Sept. 30, 2021.
 2. All accounts that complete the Rebate Claim Process on or before Dec. 31 will receive the rebate payment no later than Jan. 30, 2022.
 3. All accounts that complete the Rebate Claim Process on or before Mar. 31 will receive the rebate payment no later than April 30, 2022.
